This is a proceeding under the Federal Crop Insurance Act (7 U.S.C. §§ 1501 – 1524); the regulations promulgated thereunder (7 C.F.R. §§ 400.451 – 400.458); and the Rules of Practice Governing Formal Adjudicatory Proceedings Instituted by the Secretary Under Various Statutes (7 C.F.R. §§ 1.130 – 1.151). The matter initiated on June 3, 2019, with a Complaint filed by the Manager of the Federal Crop Insurance Corporation, United States Department of Agriculture (“Complainant”), against Lonnie Travis Johnson.

On April 8, 2021, Complainant filed a “Withdrawal of Complaint” in the above-captioned docket.<sup>1</sup> Complainant states: “It is impractical for Complainant to proceed with the administrative hearing due to ongoing investigative, audit and/or law enforcement activities
