1. On May 17, 2022, I, Judge Jill S. Clifton, upheld the March 14, 2022 APHIS denial of Petitioners’ Animal Welfare Act relicensure application that requested to add species (felids) and to add a location (Petitioners’ residence). APHIS’s March 14, 2022 denial letter was issued by the Assistant Deputy Administrator, Animal Care, APHIS, USDA, and is Government’s Exhibit 12 and was attached to Petitioners’ Petition.
2. On May 17, 2022, I ordered that the Petitioners may reapply for Animal Welfare Act relicensing one year from when my Decision and Order (issued orally, from the bench) becomes final and effective. Petitioners advised they won’t be appealing, in an email dated May 23, 2022 from Petitioner April Cicchelli to Erin Hoagland and Jill Clifton, both with the USDA Office of Hearings and Appeals, Office of Administrative Law Judges.
3. Consequently, to clarify the beginning and end of the one year period of waiting, I pronounce that my Decision and Order is final and effective as of May 17, 2022; and that the one year that Petitioners must wait to reapply to relicensure, runs from **May 17, 2022** through **May 17, 2023**.

Copies of this clarification “One Year Before Reapplying Began May 17, 2022 and Ends May 17, 2023” shall be sent by the Hearing Clerk to each of the parties.
