**CONSENT DECISION AS TO  
RESPONDENT KRISTINA MAUZY,  
AN INDIVIDUAL, D/B/A OLE  
MCMAUZY KENNEL**

This proceeding was instituted under the Animal Welfare Act, as amended (7 U.S.C. § 2131 et seq.) (the "Act"), by a complaint filed by the Administrator, Animal and Plant Health Inspection Service, United States Department of Agriculture, alleging that the respondent willfully violated the Act and the regulations and standards issued pursuant to the Act (9 C.F.R. § 1.1 et seq.) (the "Regulations"). This decision is entered pursuant to the consent decision provisions of the Rules of Practice applicable to this proceeding (7 C.F.R. § 1.138).

Respondent Kristina Mauzy d/b/a Ole McMauzy Kennel ("Respondent") admits the jurisdictional allegations in the complaint and specifically admits that the Secretary has jurisdiction in this matter, neither admits nor denies the remaining allegations, waives oral hearing and further procedure, and consents and agrees, for the purpose of settling this proceeding, to the entry of this decision.

The complainant agrees to the entry of this decision.

**FINDINGS OF FACT**

1. Respondent Kristina Mauzy (formally known as Kristina Harris) is an individual whose mailing address is Rural Route 1, Box 54, Baring, Missouri 63531.

2. Respondent Kristina Mauzy does business as Ole McMaury Kennel, believed to be an unincorporated association or partnership with the mailing address Rural Route 1, Box 54, Baring, Missouri 63531.

3. Previously, Kristina Mauzy (then, Kristina Harris) did business as Ole McMaury Kennel together with her now deceased husband Tom Mauzy.

4. Respondent Kristina Mauzy d/b/a Ole McMaury Kennel ("Respondent"), at all material times mentioned herein, was operating as a breeder, as defined in the Act and Regulations.

5. At all material times mentioned herein, Respondent has held Animal Welfare Act license number 43-A-4032, originally issued to "Kristina Harris & Tom Mauzy DBA: Ole McMaury Kennel." On or about May 18, 2005, Respondent Kristina Mauzy requested that APHIS change the name on Animal Welfare Act license number 43-A-4032 to "Kristina Mauzy."

#### CONCLUSION

Respondents having admitted the jurisdictional facts and the parties having agreed to the entry of this decision, such decision will be entered.

#### ORDER

1. Respondent, her agents and employees, successors and assigns, directly or through any corporate or other device, shall cease and desist from violating the Act and the Regulations issued thereunder, and in particular, shall cease and desist from engaging in any activity regulated under the Act and/or Regulations;


2. Respondent's Animal Welfare Act license number 43-A-4032 is hereby revoked.

3. Respondent Kristina Mauzy, an individual, d/b/a Ole McMaury Kennel is assessed a civil penalty in the amount of \$500, which shall be held in abeyance, provided Respondent does not engage in any activity regulated under the Act and/or Regulations for twenty (20) months.

4. The provisions of this order shall become effective on the first day after service of this decision on the respondents.

5. Copies of this decision shall be served upon the parties.
