)	CONSENT DECISION AND ORDER
Respondents.)	AS TO ALICE HAUN

This proceeding was instituted under the Horse Protection Act ("Act"), as amended (15 U.S.C. § 1821 et seq.), by a complaint filed by the Administrator, Animal and Plant Health Inspection Service, United States Department of Agriculture, alleging that the respondents violated the Act. This decision is entered pursuant to the consent decision provisions of the Rules of Practice applicable to this proceeding (7 C.F.R. § 1.138).

Respondent admits the jurisdictional allegations in the complaint and specifically admits that the Secretary has jurisdiction in this matter, neither admits nor denies the remaining allegations, waives oral hearing and further procedure, and consents and agrees for the purpose of settling this proceeding, to the entry of this decision.

The Complainant agrees to the entry of this decision.

Findings of Fact

1. Respondent Alice Haun is an individual whose mailing address is 15072 Sunset Drive, Northport, Alabama 35475. At all material times herein, and between December 14, 1996 and April 27, 2003, respondent Haun was registered as the owner of "Ultimate Game."
2. On March 21, 2002, respondent Alice Haun allowed the entry of "Ultimate

Game” as entry number 422 in class 27 at the 34th Annual National Walking Horse Trainers Show in Shelbyville, Tennessee for purposes of showing or exhibiting the horse.

Conclusions

Respondent having admitted the jurisdictional facts and the parties having agreed to the entry of this decision, such decision will be entered.

Order

1. Respondent Alice Haun is disqualified for one year from showing, exhibiting, or entering any horse, directly or indirectly through any agent, employec, or other device, and from judging, managing or otherwise participating in any horse show, horse exhibition, or horse sale or auction. “Participating” means engaging in any activity beyond that of a spectator, and includes, without limitation, transporting or arranging for the transportation of horses to or from equine events, personally giving instructions to exhibitors, being present in the warm-up or inspection areas, or in any area where spcctators are not allowed, and financing the participation of others in equine events.

2. Respondent is assessed a civil penalty of \$500. The civil penalty shall be paid by certified check or money order made payable to the Treasurer of the United States and sent to:




payment is in reference to HPA Docket No. 06-0005.

This Order shall have the same effect as if entered after a full hearing and shall become effective on the first day after service of this decision on the respondent.


